On September 8, 2025, Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. (collectively “Samsung”) filed a Petition for *Inter Partes* Review seeking review of claims 1-12 of U.S. Patent No. 12,250,452. On January 9, 2026, the Patent Trial and Appeal Board issued its Decision Denying Institution of Post-Grant Review (Paper No. 13).

Petitioner challenged 12 claims, and paid post-institution fees, calculated as follows:
