REQUEST FOR REFUND OF POST-INSTITUTION FEES

Pursuant to the Patent and Trademark Office’s Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232-4234 (Jan. 18, 2013), Samsung Electronics America, Inc. and Samsung Electronics Co. LTD. (“Petitioners”) respectfully request a refund of post-institution fees in the amount of \$33,725 to be paid to Deposit Account No. 000505708.

On September 29, 2025, Petitioners filed a Petition for *Inter Partes* review of U.S. Patent No. 8,923,754 (“the ‘754 patent”). (Paper 3.) On January 27, 2026, the Acting Director issued an Discretionary Denial Decision. (Paper 12.)
