**PETITIONER'S *SOTERA* STIPULATION**

If *inter partes* review is instituted in IPR2025-01596, unless institution is later vacated, reversed, terminated prior to a final decision, or otherwise withdrawn by rehearing or Director Review, Petitioner Shenzhen Qianfenyi Intelligent Technology Co., Ltd. (“Maxeye”) stipulates that, consistent with *Sotera Wireless, Inc. v. Masimo Corp.*, IPR2020-01019, Paper 12 at 13-14 (PTAB Dec. 1, 2020) (precedential as to § II.A), Maxeye will not pursue in Case No. 2:24-cv-702-JRG in the United States District Court for the Eastern District of Texas, Marshall Division, against the ’277 patent, (i) the specific grounds asserted in IPR2025-01596, or (ii) any other ground that was raised or could have been reasonably raised in an IPR (i.e., any ground that could be raised under §§ 102 or 103 on the basis of prior art patents or printed publications).

Please take notice that Petitioner also filed a *Sotera* Stipulation in *Wacom Co. Ltd. v. Shenzhen Qianfenyi Intelligent Technology Co., Ltd.*, 2:24-cv-00702-JRG (E.D. Tex.) on November 5, 2025 (Dkt. 61).
