EXHIBIT A

Patent Assignment.

(d) any other rights in the inventions described in any of (a), (b) or (c) including rights to future patent applications and all rights of cooperation assigned or granted by a third party;

(all of the foregoing in (1), collectively, the "Assigned Patents");

(2) the right to sue third parties for infringement (including but not limited to past, present and future infringement, damages and injunctive relief) of any of the Assigned Patents based on activities occurring prior to the execution date hereof or hereafter; and

(3) any current or future right to receive royalties based on any of the foregoing in (1) or (2); and

(B) agrees upon reasonable request (and at the expense) of Buyer to, and if Seller is unable or unwilling to do so authorizes Buyer to act in Seller's name to: execute all oaths, assignments, powers, and any other papers necessary to perform Seller's obligations hereunder and reasonably cooperate with Buyer to perform Seller's obligations hereunder, in each case, related to securing Buyer's rights under the Assignment.



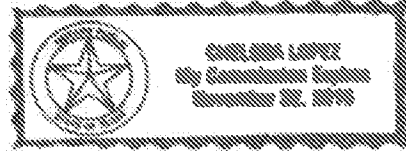
