**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

Petitioner's Request For Refund of Post Institution Fees

Petitioner Terumo BCT, Inc. ("Petitioner") hereby requests a refund for the post-institution fees which were previously paid. On October 17, 2025, Petitioner filed a petition for *inter partes* review of claims 1-30 of U.S. Patent 10,980,926 (Paper 1). Petitioner paid the USPTO a total of \$65,975.00 via USPTO Deposit Account No. 53065, which included a \$23,750.00 payment for the *inter partes* review request fee in accordance with 37 C.F.R. § 42.15(a)(1), a \$28,125.00 payment for the post-institution fee in accordance with 37 C.F.R. § 42.15(a)(2), a \$4,700.00 payment for the *inter partes* review request of each claim in excess of 20 fee in accordance with 37 C.F.R. § 42.15(a)(3), and a \$9,400.00 payment for the *inter partes* review post-institution claim in excess of 20 fee in accordance with 37 C.F.R. § 42.15(a)(4). On March 10, 2026, the Board issued an order denying institution of this proceeding (Paper No. 15). Petitioner therefore requests a refund of the \$37,525.00 total post-institution fees, including the \$28,125.00 *inter partes* review post-institution fee and \$9,400.00 *inter partes* review post-institution claim in excess of 20 fee, that was previously paid at the time of filing in the case of IPR2026-00046.
