PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

On November 5, 2025, Disney Entertainment & Sports LLC (“Petitioner”) filed a Petition for Inter Partes Review of U.S. Patent No. 8,542,705 (“the ’705 Patent”), which was assigned AIA review number IPR2026-00052 by the Board. The petition requested Inter Partes review of Claims 1, 2, 4–9, 11–16, and 18–20 of the ’705 Patent. Accordingly, Petitioner submitted filing fees totaling \$51,875, of which \$28,125 constituted post-institution fees as specified by 37 C.F.R. § 42.15(a).

Petitioner moved to dismiss on December 24, 2025. The Board granted dismissal on February 25, 2026. Because Inter Partes review of the ’705 Patent in IPR2026-00052 is now dismissed, Petitioner requests a refund of post-institution fees in the amount of \$28,125. Upon review and approval of this request, Petitioner respectfully requests that the Board credit these post institution fees to Deposit Account Number 50-0639 from which they were originally submitted.
