Honorable Director and Board,

It recently has come to Patent Owner's attention that it filed discretionary denial briefs for IPR2026-00104, 00105, 00107 and 00109 that were mistakenly over the page limits. To resolve this issue, Patent Owner respectfully requests authorization to file corrected discretionary denial briefs that comply with the 20-page limit.

In preparing the corrected briefs, Patent Owner specifically avoided adding new arguments, but merely deleted text and—in some cases—replaced it with shorter summary statements. Attached for your consideration are redline versions of the proposed corrected briefs. With the Director and Board's approval, we will file clean versions of the same briefs.

Patent Owner has conferred with Petitioner and provided the corrected briefs for review by Petitioner's counsel. Petitioner indicated that it does not oppose Patent Owner's request, but Petitioner requests a one-week extension for its opposition brief deadlines in view of the revisions to the corrected briefs. Patent Owner does not oppose Petitioner's requested extension.
