Hi Andy –

Thanks for sending. As a reminder, Gemalto did look at some of the portfolio about 15 months ago, when I was trying to sell the international applications independently from the US patents. They passed at that time, but I don't know how detailed they looked at it. I went through an ex Motorola friend at that time to reach Gemalto.

The real next step to determine if they actually are interested would be for them to ask for the "evidence of use" (EOU) charts. It's referenced in the summary, and that really is the next logical step if someone is looking seriously at the patents. But, I would wait a couple of weeks for them to actually ask for the EOU charts. If they don't even ask to see EOU, then that suggests to me they aren't interested. I sent you one example EOU chart, but I have four different ones covering four different standard cases:

- i. Device supporting bootstrap profile and then operational profile
- ii. Device supporting changing profiles
- iii. Network supporting bootstrap profile and then operational profile
- iv. Network supporting changing profiles

I guess Interdigital would now be around the same stage as Gemalto, right?

Also, is there any progress with either Qualcomm or Samsung?
