Pursuant to 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(c), Petitioners Vivint Smart Home, Inc. and NRG Energy, Inc. (“Petitioners”) and Patent Owner Malikia Innovations Ltd. (“Patent Owner”) hereby jointly request that a true copy of their settlement agreement (the “Agreement”), filed concurrently herewith as Exhibit 2001, be treated as business confidential information and be kept separate from the file for this *inter partes* review (“IPR”) proceeding. Concurrently with the filing of this Request, Petitioner and Patent Owner are filing a Joint Motion to Terminate.
