Plaintiff WinView, Inc. and Defendants DraftKings Inc. (a Nevada corporation), DraftKings Inc. (a Delaware corporation), and Crown Gaming Inc. (a Delaware corporation) (together, “the Parties”), hereby stipulate and agree as follows:

WHEREAS, in its November 12, 2024 letter to the Court (Dkt. 63), without being provided with consideration from DraftKings, Plaintiff stated that it would voluntarily dismiss with prejudice its infringement claims based on U.S. Patent No. 9,930,730 (the “’730 Patent”) and U.S. Patent No. 9,878,243 (the “’243 Patent”); and

WHEREAS, on December 5, 2024, the Court ordered Plaintiff “to file a stipulation of dismissal” as to the ’730 Patent and the ’243 Patent (Dkt. 65.);

NOW THEREFORE, pursuant to Fed. R. Civ. P. 41, Plaintiff’s claims based on the ’730 Patent and the ’243 Patent shall be dismissed with prejudice, with each party to bear its own costs, expenses, and fees as to the ’730 Patent and the ’243 Patent.
