			InterDigital, Inc., InterDigital VC Holdings, Inc., and InterDigital Madison Patent Holdings, SAS have filed a patent infringement suit in the U.S. District Court for the Eastern District of Virginia against Amazon.com Services LLC, represented by McKool Smith, P.C. The complaint asserts four patents related to digital video technology, including methods for geometric frame partitioning, generalized bi-prediction, improved intra chroma encoding/decoding, and color decision metadata generation. The accused products include Amazon's Fire TV and Echo Show devices capable of AV1 video decoding and HDR playback. Plaintiffs allege direct and indirect infringement under 35 U.S.C. § 271, including willful infringement, and seek damages, enhanced damages under 35 U.S.C. § 284, attorneys' fees under 35 U.S.C. § 285, and a permanent injunction. Jurisdiction is based on 28 U.S.C. §§ 1331 and 1338(a), with venue asserted as proper due to Amazon's significant business presence in the district.
